•3. In that conversation Jeremy Peters said that he had had an instant messaging exchange on April 10, 2007 with a person by the name of J.J. McCullough at Simon Fraser University. Jeremy Peters described the exchange in which my name had come up.

4. I asked Jeremy Peters to send me a copy of the instant messaging exchange which he had had with Mr. McCullough and he did so the following day.
