National Executive Report Canadian Federation of Students (-Services) May 1991

The National Executive has meet twice since the October General Meeting. During the six month term, Joe Seymour was accepted as the Aboriginal Students National Executive Representative, Pam Frache resigned as the British Columbia representative and was replaced with Brad Lavigne at the January National Executive meeting. Jamie McEvoy was accepted as the British Columbia representative at the National Executive meeting in May.

The National Executive is responsible for upholding the objectives of the Federation and the day to day operations of the Federation. The Executive is responsible for the management of both the Ottawa and Toronto offices and works to ensure the membership directives adopted at each General meeting are completed.

Following the October General Meeting, the National Executive meet for two days to review and discuss the General Meeting. The committee and constituency reports were discussed and responsibilities assigned for each motion adopted by the membership. Jo-Anne McCutcheon was elected to replace Pam Frache on the Labour Management Committee for management.

The January National Executive meeting was held in Ottawa from January 4-7, 1991. Various issues were discussed including but not limited to:

- A) Legal case applying for funding from the Kevin Coleman Students Rights Defence Fund National Executive allocated an initial amount of \$ 2500 to cover this case of copyright infringement.
- B) Presentations from Keith Spicer, head of the Citizen's forum on National Unity and Paul Houston from the Students' Forum on Canadian unity. The National Executive adopted a motion encouraging all members to participate in all forums on the issue of Canada's future.
- C) A presentation from the department of Secretary of State, Official Languages to look at our level of bilingualism within the Federation.
- D) Upcoming IUS Special Congress the National Executive decided to send three people to the meeting in Prague.
- E) The possibilities of the Federation hosting an international meeting. The National Executive decided to pursue such a meeting in conjunction with IUS.
- F) A review of the Programs Committee report with discussion on the upcoming StudentSaver program. The National Executive adopted a motion to produce a non-StudentSaver envelope consisting of advertisements, available to non-members only, to increase the

Federation's profit margin.

- G) The National Executive asked to investigate the possibilities of charging differential fees for the ISIC for Federation members.
- H) A lengthy discussion about the Services fees that have been placed in trust by several members.
- I) The National Executive adopted a motion condemning the book "American Psycho", a book condoning violence against women.
- J) Extensive review of issues and lobby work Campus Employment Centre closures, the Stewart Smith Commission, Cook-Bennett Review of Canada Student Loans, Challenge Announcement scheduled for February, GST campaign with Action Canada Network, Federal budget 1991, and our withdrawal from the Consortium.
- K) Review of upcoming referenda, campaigns, General Meeting in Lethbridge, and other issues.
- L) The National Executive recognized the job description of the Financial Coordinator as that of a regular employee. The position was placed back in the Bargaining unit.
- M) The National Executive adopted the following motion concerning the Gulf War:
 - **BE IT RESOLVED THAT** the Federation take part in national, international and local coalitions that are opposed to war in the Gulf;
 - BE IT RESOLVED THAT the Federation believes that the people of Kuwait have a right to pursue self-determination;
 - BE IT RESOLVED THAT the Canadian government not cut social programmes as a means to fund the war effort;
 - BE IT RESOLVED THAT the Federation oppose war as a means to solve the crisis in the Gulf;
 - BE IT RESOLVED THAT the Federation encourage the Canadian Government to use its role within the United Nations to address all other violations of international law, such as the US invasion of Panama and other Arab territories in the Middle East:
 - **BE IT RESOLVED THAT** the Federation encourage the Canadian government to increase funding for research and application of alternative energy sources and to make Canada more self-sufficient on energy.

The Federation has many new staff people. Catherine Remus was hired in January as our new Government Relations Officer, Jocelyn Charron was hired in mid-February as Communications Officer, Sandra Sabey was hired in January as the National Fieldworker for Alberta and Michelle Brazil was hired as our National Fieldworker in Nova Scotia/Newfoundland/Labrador in April. Peter Block left the Federation as Canadian Programming Director in December and has been replaced with David Dose. Larry Hansen, Communications and

Special Projects, left the Federation in January. Hugh Leighton was hired to work with the Health and Dental Plans Program in January.

The Federation ran several national campaigns since October including:

- Anti-Racism day on November 21st
- ° Day of Reflection on December 6th
- ° National Week of Action last week of January
- ° If You Love Education Day February 14th
- International Women's Week March 4-8th

Several referenda took place this term. The Federation suffered in the area of membership growth as seen by the following results:

- McMaster Students' Union re-affirmation referendum successful
- Queen's University Alma Mater Society unsuccessful
- St. Francis Xavier University Students Union withdrawal successful
- Mount Royal College Student Association unsuccessful
- University of Calgary Students' Union unsuccessful
- Brock University Students' Union unsuccessful
- Alberta College of Art Student Association withdrawal successful
- University of Victoria Graduate Student Association unsuccessful

The Federation hosted an international meeting from May 1-4st in Ottawa. The seminar, entitled "Educational Reforms and Policies in Industrialized Countries" was very successful. National Union of Students from Japan, USSR, Belgium, Finland and Czechoslovakia attended the seminar. The European Student Information Bureau, a regional body, sent a representative, as did IUS.

Both the Toronto office and the Ottawa office have new addresses. The Toronto office moved in the new year to 243 College Street. The Ottawa office will be moving immediately following the General Meeting to 170 Metcalfe Street. Both offices were very crowded and often the staff found it difficult to work in this environment. The new offices should create a positive working environment for the Federation.
