She said that the Centre for Campus Organising, based in Boston, Massachusetts, sent a letter of greetings to the Federation. She introduced the members of the National Executive and staff of the Federation.

Carlyle said that the various students' associations which now comprise the College of the North Atlantic Students' Association were granted prospective membership at the May 1995 and May 1996 national general meetings. She said that the following students' associations were granted prospective membership in the Federation at that time: Cabot College; Central Newfoundland Regional College; Eastern College and Labrador College Students' Associations. She said that the Central Newfoundland Regional College Students' Association applied for and was granted full membership at the May 1996 national general meeting after the membership voted overwhelmingly for full membership. She said that in the summer of 1997 the aforementioned colleges were amalgamated into one institution, the College of the North Atlantic. She said that a decision was made to amalgamate the students' associations as well and as a result the students at the three campuses; the Central Newfoundland Regional College Students' Associations remain full members of the Federation while students on the other campuses remain prospective members. She said that to accommodate the unique situation, the National Executive is recommending that the prospective membership of the College of the North Atlantic be extended. She said that a full membership referendum will be conducted before the May 1999 national general meeting.

9. PRESENTATION BY STAFF RELATIONS OFFICER

Story said that her role as Staff Relations Officer is to act as the contact person in dealing with the staff on a formal level. She said that the employees of the Federation are unionised with the Canadian Union of Public Employees, Local 1281. She said that the rights and responsibilities of the employer rest with the members of the National Executive. She said that the collective agreement is a public document and is available to the membership. She said that the collective agreement gives staff full participation rights at all meetings of the Federation with the exception of meetings of the employer relating to discipline, discharge and collective bargaining. She said that employees are non-voting and have speaking rights at all meetings in accordance with the collective agreement and the Bylaws. She said that the staff also have the right to work in an environment free of discrimination and harassment. She said that any work related complaints should be directed to members of the National Executive.

10. INTRODUCTION OF HARASSMENT ADVISORS

Tara Connolly and Florence Loh introduced themselves as the harassment advisors for the national general meeting. Connolly said that many people can assist delegates in their work but the advisors are there to assist them if they encounter a situation that will impede their ability to participate fully in the meeting. She encouraged delegates to review the harassment procedure in the policy manual. She said that the Federation has the harassment policy in an attempt to highlight that demeaning or abusive behaviour is unacceptable as a form of communication in this environment. She said that delegates should enter into the week in the spirit of constructive, responsible conflict. She said that handled responsibly conflict can be a catalyst for change and lead to a depth of understanding and clarity which might otherwise be absent. She said that non-verbal communication is strong and people often react to it first. She said that it is also important to recognise that some delegates are not speaking in their first language and to be cognisant and respectful of this. She said that delegates should be mindful of their health at the meeting as it has a direct impact on their mood. She said that she and Loh are bound by strict confidentiality.

11. REVIEW OF STANDING SUB-COMMITTEES OF PLENARY

Sioufi said that as per Standing Resolution 1.1 the following subcommittees are struck at every national general meeting:

- Budget Committee;
- Campaigns and Government Relations Committee;
- National Education and Student Rights Committee; and

Sioufi said that the roles and responsibilities of the sub-committees are outlined in the delegate's general meeting binders.

12. PREPARATION FOR NATIONAL EXECUTIVE ELECTIONS

a. Introduction of Chief Returning Officer(s)

Sioufi said that as per Bylaw 6, Article 7, the National Executive appointed Ontario Researcher Ashkan Hashemi and Manitoba Fieldworker Kemlin Nembhard as the chief returning officers.

b. Overview of Election Schedule and Procedures

Nembhard said that the nomination period for elections started at 19:00 November 25 and would end at 22:00 November 27. She announced the positions which were open for nominations: National Chairperson; National Deputy Chairperson; National Treasurer; Travel CUTS board member, which must be a woman; Aboriginal National Executive Representative and Women's National Executive Representative. She said that the election for the Women's Representative would be a by-election and the elections for the Aboriginal Representative would be a by-election and a regular election. She said that the Aboriginal and Women's Representatives would be elected by the caucus and constituency group. She said that within the Aboriginal Caucus each member local has one vote. She said that within the Women's Constituency group every woman delegate is eligible to vote. She said that the Aboriginal and Women's National Executive Representative positions were for the remainder of the 1998-99 term. She said that the other positions would be elected by plenary and each member local has one vote.

Nembhard said that Bylaw 6 governs the elections and outlines the procedures. She said that the Standing Resolutions outline the responsibilities of the various positions. She said that a mandatory meeting of nominees will be convened following the close of nominations. She said that the details of the election procedures will be reviewed at this meeting. She said that voting would occur at 9:00 November 29.

MOTION TO ADOPT POLICY

Local 34/Local 11

Be it resolved that the following policy be adopted:

Poverty

The Federation believes that conditions of poverty have an effect on access to education, and on the quality of education while in the system. Therefore the Federation recognises the political responsibility of students to keep personal poverty in perspective, recognising personal privilege while also working against poverty in general.

A. Minimum Income Levels

The Federation recognises that the current levels of various forms of assistance has led to a need for combining two or more sources of assistance in order to survive. The Federation believes it should not be necessary to combine forms of assistance, and calls for increased levels of assistance in all forms.

The Federation:

- Recognises that fiscal decisions by governments which convert public debt into private debt and poverty, comprise a debt trap Canadians living in poverty and those living in comfort;
- Recognises a minimum which widens the gap between income level for individuals based on rates from the National Council on Welfare;
- Supports the use of National Council on Welfare low-income cut-off rates to establish levels of assistance and to determine the effectiveness of programs; and
- Supports the development of criteria based on National Council on Welfare low-income cut-off rates to determine a minimum income level for members of constituencies such as students, sole-support parents, and other situations with additional expenses associated with them.

B. The Common Experiences of Poverty

The Federation recognises that similar perceptions exist of those on social assistance and those on student assistance, such as the perception that they are "receiving a handout," and the opinion that they are bad money managers with too much time on their hands. In addition, regressive aspects of the social assistance and unemployment insurance programs are echoed in the student loan program: the clawback of assistance based on employment income earned while receiving assistance is present in all three programs. Therefore, in solidarity with individuals receiving all forms of government assistance, the Federation:

- Opposes the stereotype of those on forms of assistance as lazy or inferior
- Opposes the claw back of assistance based on earnings while receiving assistance through government social programs; and
- Opposes the deliberate setting of assistance at levels well below the low-income cut off rates determined by the National Council on Welfare.

C. Student Poverty and Student Health

The Federation:

- Recognises the cycle of poverty and stress which lead to ill health and more stress; and
- Recognises access to health services as an essential aspect of quality education; and
- Supports full, free and accessible health and support services provided by the institution, including counselling services; and
- Recognises professional and quality peer support services, while essential, do not eliminate the need for professional services.

- calls for a minimum income level for individuals based on rates from the National Council on Welfare;
- Supports the use of National Council on Welfare low-income cut-off rates to establish levels of assistance and to determine the effectiveness of programs; and
- Supports the development of criteria based on National Council on Welfare low-income cut-off rates to determine a minimum income level for members of constituencies such as students, sole-support parents, and other situations with additional expenses associated with them.

B. The Common Experiences of Poverty

The Federation recognises that similar perceptions exist of those on social assistance and those on student assistance, such as the perception that they are "receiving a handout," and the opinion that they are bad money managers with too much time on their hands. In addition, regressive aspects of the social assistance and unemployment insurance programs are echoed in the student loan program: the clawback of assistance based on employment income earned while receiving assistance is present in all three programs. Therefore, in solidarity with individuals receiving all forms of government assistance, the Federation:

- Opposes the stereotype of those on forms of assistance as lazy or inferior and recognises that widespread poverty is a direct result of our economic system;
- Opposes the claw back of assistance based on earnings while receiving assistance through government social programs; and
- Opposes the deliberate setting of assistance at levels well below the low-income cut off rates determined by the National Council on Welfare.

C. Student Poverty and Student Health

The Federation:

- Recognises the cycle of poverty and stress which lead which lead to ill health and more stress;
- Recognises access to health services as an essential aspect of quality education;
- Supports full, free and accessible health and support services provided by the institution, including counselling services; and
- Recognises the need for quality peer support services, which while essential, do not eliminate the need for professional services."

Systemic under-funding has increased the financial burden sustained by students in post-secondary institutions through up-front user fees.

The Federation believes that the government must consider the realistic costs of post-secondary education above and beyond tuition fees and ancillary fees. Furthermore, the Federation believes that student aid line item levels should be adjusted annually to reflect the costs associated with the attainment of a post-secondary education, and that this adjustment should reflect regional differences in the cost of obtaining a post-secondary education (refer to Issues Policy: Student Aid).

Need is defined as circumstances requiring some course of action in times of difficulty or crisis, often described as destitution or poverty in extreme circumstances. The Federation recognises there are varying financial requirements between students pursuing studies in colleges/technical institutes, undergraduate programs, and graduate programs. The Federation also recognises the unique financial needs of students with disabilities and international students. Therefore the Federation recognises that it is essential to identify various parameters in determining the financial needs of these different groups.

The following criteria should be included in any assessment of need:

Living Expenses:

- rent/mortgage
- car/transportation
- monthly bills
- food/household/hygiene
- trips home
- clothing
- moving costs

Post-secondary Education:

- up-front user fees (tuition, ancillary, etc.)
- books/program supplies/equipment
- currently held scholarships, stipends, research granting council funding

Research:

- travel/conferences
- publishing
- thesis production costs
- academic subscriptions

Employment:

- full-time versus part-time
- income
- assets

Debt:

- previous student loans
- line of credit
- credit cards

Other:

- disability
- age/mature status/ grad
- dependants

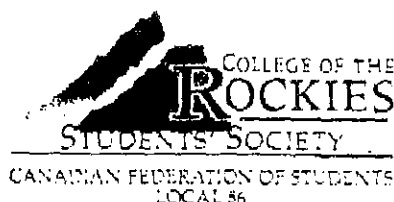

The Speaker declared quorum to have been achieved.

Local 9 delegate Stacey Fayant and Saskatchewan Component Chairperson Jeni Minion rose on a point of personal privilege. Fayant said that a letter written by Colin Hall, a member of the Local 9 board, was distributed to delegates by another delegate at the general meeting. She said that she received a fax directing her to move a motion which reads as follows:

Whereas Local 9 of the Canadian Federation of Students has sent Stacey Fayant as it's representative; and

Whereas the reason a delegate was sent by local 9 was to support Lanna Many Grey Horses in her struggle for justice in dealing with the Federation; therefore

Be it resolved that Stacey Fayant be directed to vote with Lanna Many Grey Horses at all times during the general meeting;

Be it further resolved that Stacy Fayant's be directed to move a motion calling for the national office to rescind the complaints submitted by the YES side committee following the de-Federation referendum at local 9;

Be it further resolved that Stacy Fayant motivate the motion by calling to attention to the fact that the accusation that Colin Hall and Jason Stevens were harassing poll clerks and intimidating voters is inappropriate and unfounded; and

Be it further resolved that Stacey Fayant have all of her votes recorded and included in the minutes of the general meeting.

Fayant said that as the first document was distributed publicly and has interfered with her ability to participate in the meeting she wishes to address it so she can participate fully in the rest of the meeting. She said that she would read from her notes as she was very upset. She said that she is upset by both letters for many reasons but primarily because they reflect the ongoing harassment she and Jeni have endured on campus, particularly since the de-Federation referendum campaign at local 9 began. She said that she would not move the motion as directed because the content is a lie and there is clear evidence that the individuals named were harassing poll clerks. She said that it is much like the harassment she and Jeni have faced while attempting to be active on their campus. She said that they have been harassed because they do not always agree with the elected members on the board of directors at the University of Regina Students' Union, in particular because she and Jeni support the work of the Canadian Federation of Students. She said that the debate on whether or not to send her to the general meeting took two hours because these same people did not want Fayant to be sent as an aboriginal delegate. She said that once the decision was made no direction was provided, instead they waited until she had left for the meeting, when in her absence they may have adopted the motions which were distributed at the general meeting. She said that she was sent by the local to participate in Aboriginal Caucus, to participate as a full delegate at the general meeting. She said that she wanted to emphasise that it is not that she agrees nor disagrees with Many Grey Horses on issues but that in her absence people have attempted to deny her the right to participate in and be influenced by debate, to make decisions in good conscience, to make decisions that she believes are in the best interests of her constituents. She said that she has risen to explain that she will not be following the direction provided but will be voting with her conscience. She asked for the support of her decision and to allow her the dignity that the members of her board of directors have sought to deny.

2. BUSINESS TABLED FROM OPENING PLENARY

Whereas the Federation "supports the introduction, the encouragement, and enhancement of...a welcoming environment for aboriginal students"; and

Whereas the Federation "opposes patriarchy and gender oppression...[and]opposes sexism"; and

Whereas the Federation states that women students have the right to "an educational environment free of advertisements, entertainment programming, and/or materials which promote violence against women, sexual stereotyping and/or discrimination"; and

Whereas Federation activities are part of the Canadian educational environment; and

Whereas Bylaw 6.5 states the National Chairperson, Deputy Chairperson and Treasurer may be removed from office by a 2/3 vote at a national general meeting or by mail out vote; therefore

Be it resolved that a vote be taken at opening plenary to remove the National Chairperson, Deputy Chairperson and Treasurer from office.

Local 5 delegate Elvira Balakshin said that there have been many discussions about the rationale for the motion. She said that the motion was submitted mainly for strategic reasons, and also to encourage people to speak to the local 5 delegation directly and to encourage debate. She said that upon reading the public statement issued by the National Executive the delegation was surprised and pleased however they are still displeased because they feel the statement is inadequate. She said that local 5 believed bringing this motion forward was the only method to instigate debate.

Local 19 delegate Holly Baines said that Local 19 was pleased the motion was presented because it motivated debate. She said that the local was happy a statement was released but is disappointed it took so long for the release. She said that she is disappointed that the debate did not occur in opening plenary as it could have informed other areas of debate.

Local 45 delegate Dale Kirby said that although he respects the reasons for presenting the motion, people without access to the same information might believe that it is destructive. He said that members should pursue other methods when addressing similar issues.

Local 54 delegate Dorte said that her local supported the motion. She said that the local has concerns regarding other issues but the incident between a Federation employee and Many Grey Horses overshadows any other concerns. She said that the statement was released a year following the incident and months after member locals first began requesting a public statement. She said that Local 54 contacted the national office in August and it was after she posted an article, which appeared in the *Ontario*, on the listserver before she received a response. She said that National Chairperson Carlyle contacted her but she was dissatisfied with the National Chairperson's response. She said that the at-large members of the National Executive were aware of the incident through various means.

Local 72 delegate Diane Davis said that she disputes the argument that bringing forward a motion is the only way to have the issues debated. She said that the component has been split over this issue and the majority of individuals frustrated by the lack of solutions. She said that the motion is punitive towards individuals who have worked for the Federation and she urged delegates to vote against it.

Local 1 delegate James Pratt said that he is opposed to the motion. He said that the incident is difficult to address at a personal level and impossible to respond to satisfactorily as a representative for an entire organisation. He said that there is a possibility that the National Executive did not respond quickly enough. He said that the membership is now responsible for addressing this issue and developing an appropriate response, like the inquiry. He said that although impeachment may help vindicate people it will harm the organisation.

Local 45 delegate Lou Walsh said that he was opposed to the motion. He said that he recognises that the issue which initiated this motion important but the manner in which it is being addressed is not productive. He said that impeachment will not resolve the problem. He said that the implications of the motion are more complex than it appears.

Local 86 delegate Kevin Gedling said that he is in favour of the motion. He said that the organisation can withstand an impeachment vote and it will not tear the organisation apart. He said that impeachment is one of the fundamental rights of membership.

Local 24 delegate Erin George said that she is opposed to the motion. She said that if the vote is successful the only people that will benefit are those who support the neo-conservative, corporate agenda that the Federation fights against. She said that the lack of leadership in the Federation will not benefit the student movement nor the membership.

Local 54 delegate Dorte said that she shares some similar concerns with those speaking against the motion. She said that no National Executive member has taken the situation seriously and no one has addressed the situation in a way that validates the seriousness of it. She said that she was advised to question the woman who was assaulted and the man who assaulted her to get a better perspective. She said that when the leadership gives this type of advice it cannot be trusted. She said that she calls on any delegate to prove that the leadership can be trusted and to propose another way to address the situation and to regain confidence in the leadership and the organisation.

3. PRESENTATION OF THE REPORT OF THE NATIONAL EXECUTIVE

Carlyle said that the report includes the activities undertaken between May 20, 1998 and November 24, 1998.

Campaigns and Government Relations

Carlyle said that campaigns are defined as plans of action that the Federation adopts in pursuit of its external goals. She said that either directly or indirectly, most of the Federation's resources are applied to its campaigns. She said that the campaign for an accessible, public post-secondary education was the primary campaign component and it was divided into two chronological segments. She said that the first was the October 13-16, 1998 Days of Action. She said that the focus was on increased core funding and specific improvements and new measures in student financial assistance. She said that the campaign has laid the ground work for future actions. She said that Days of Action media highlights include; coverage by major dailies and weeklies including the CBC National News, CBC television, news, CBC radio in French and English, the *National Post*, the *Globe and Mail*, *Macleans* magazine, *Le Devoir*, *la Presse* and *le Journal de Montreal*. She said that the campaign for increased funding for research granting councils attracted attention from key Liberal caucus members, including Finance Minister Paul Martin, who has suggested that increases to research councils funding are on the horizon for 1999 Federal budget.

Carlyle said that there are some exciting new developments in the campaign to oppose the amendments to the bankruptcy and insolvency act. She said that a number of different approaches have been employed to maintain the pressure and profile of the campaign. She said that the Federation has supported New

Democratic Party (NDP) Post-Secondary Education critic Libby Davies' private member's bill to repeal the amendments to the act. She said that the initial stages of a charter challenge have also been undertaken. She said that research on this issue is ongoing.

Carlyle said that the Federation has undertaken a campaign demanding a transformation of the Millennium Scholarship Foundation. She said that one of the demands is that it be a publicly administered system of national grants. She said that the Federation has been involved in a number of different efforts, including the consultation regarding the Foundation. She said that the Federation has been one of few groups chosen to consult with. She said that letters have been sent from the national office, member locals and provincial components. She said that the Federation has also been invited to participate in nominating people for the various positions and to be involved in the development of the selection criteria for the selection of members of the board of the Millennium Scholarship Foundation. She said that throughout the process it has been iterated that the structure of the foundation must change.

Carlyle said that work on a number of campaigns has just begun. She said that it includes: the campaign against corporate rule in post-secondary education; the campaign against the use of Rohypnol and date rape, an updated version of an ongoing campaign; the campaign against youth and student unemployment; campaign against the use of the homophobic blood donor questionnaire used by the Red Cross; campaign against funding cutbacks to services for students with disabilities. She said that research has been conducted on the changes to the Vocational Rehabilitation Programme, a funding mechanism which is jointly contributed to by the Federal and provincial governments. She said that the Federation has also received increased attention for its long-standing proposal for a Post-Secondary Education Agreement. She said that it was addressed during the Finance Committee hearings, October 26, 1998.

Internal Affairs

Carlyle said that outgoing Nova Scotia Representative Jessica Squires has been hired as the interim Nova Scotia/Prince Edward Island Fieldworker interim. She said that the hiring process is in the initial stages for the following positions: Aboriginal Caucus Coordinator; Graduate Caucus Coordinator (interim); and Government Relations Coordinator (interim).

Communications Issues

Carlyle said that the Federation's web site has been renovated to include: improvements to the side menu bar; pop up boxes containing important features of the site and Federation work; and information on the October 1998 Days of Action. She said that a counter will also be added to track the number of visitors to the web site. She said that the graduate students' web site is in progress.

Carlyle said that the directive to produce generic Federation promotional materials has been fulfilled and samples will be presented to the National Executive for consideration at the next National Executive meeting.

Membership Development

Carlyle said that members at Local 9 voted to remain members of the Federation. She said that 980 votes were cast and 654 (66.6%) students voted yes to continuing membership, 326 (33.4%) voted opposed and 8 members spoiled their ballots. She said that the voter turnout of 14% was considered high for the local.

Programmes

Carlyle said that a number of changes have been made to the International Student Identity Card (ISIC). She said that the card has a new design and new promotional materials are available.

Carlyle said that local 11 joined the National Student Health Network (NSHN). She said that 11 member locals of the Federation are members of the Network. She said that in September 1998 a new programme was introduced called Student Options. She said that it is an optional dental and health plan for graduating students and those students who do not have access to a group health plan.

Finances

National Treasurer Joey Hansen said that each year the Federation operates with a budget of approximately \$2 million in revenue. He said that the budget for the current fiscal year has a combined surplus and recapitalisation in Travel CUTS of \$290,000. He said that the results for the 1997-98 year show that during 1998 the Federation ran a surplus of approximately \$400,000. He said that the Federation has an accumulated debt owed to Travel CUTS. He said that throughout the late 1980's and early 1990's the Federation purchased shares in the company but was unable to pay for those shares. He said that during the 1996-97 year the debt was approximately \$750,000. He said that the amount, referred to as the net worth gap, has since been reduced to \$100,000.

Hansen said that the Federation is incorporated as the Canadian Federation of Students and Canadian Federation of Students-Services. He said that at the May 1995 general meeting the membership voted to amalgamate the two entities. He said that it is a lengthy process but is now on hold due to a legal issue. He said that the collection of 1998-99 membership dues is proceeding smoothly. He said that the Federation's membership due is indexed to the Consumer Price Index and the current fee is \$3.17 per member. He said that a couple of former and current member locals of the Federation owe outstanding membership fees. He said that the National Executive is in the process of collecting those fees. He said that the Federation employs a travel pool to equalise travel costs to national general meetings. He said that some members are owed money through the travel pool and he is in the process of reimbursing those member locals. He said that the November 1997 general meeting resolved that the Federation's financial accounts be moved to a credit union. He said that the National Student Health Network's accounts have been transferred to Toronto but there is no credit union which can service both the Ottawa accounts and the Toronto accounts. He said that work is ongoing to secure a credit union which can fulfil the Federation's needs. He said that the November 1997 general meeting resolved that the Federation investigate alternative auditors. He said that the Federation has used Arthur Anderson since 1981 but serious concerns were raised about the work an associated company of Arthur Anderson did to support the Ontario Conservative government's work fare programme. He said that the National Executive has located an auditing firm which meets the criteria, Welch and Company. He said that the business concentrates on small businesses, unions and other non-governmental companies. He said that they do the audit for Oxfam Canada and Canadian Nurses Federation.

Coalitions and International Relations

National Deputy Chairperson Story said that as a result of the ongoing fight against the Multilateral Agreement on Investment (MAI), France has withdrawn from the MAI and there is momentum building to defeat the MAI when it is presented at the World Trade Organisation. She said that Canada continues to lead the fight against the MAI and is a key player in building the movement internationally. She said that Canadian students are known to be incredibly active in this fight. She said that the Federation has funded and participated in the inquiry process, organised by the Council of Canadians.

Story said that the November 1998 National Executive meeting resolved to send an observer to East Timor for the mobilisation that has been planned by East Timorese students. She said that the Federation was invited by the East Timor student union. She said that the Federation and member locals have made financial contributions. She encouraged delegates to support the efforts to ensure that East Timor students will have access to basic supplies, like water, during their occupation.

Story said that the Federation has continued to play a fundamental role in the International Union of Students (IUS). She said that the Federation will participate in an International Union of Students Congress in 1998-99 and will continue working towards rebuilding a formal international student movement. She said that she and British Columbia Chairperson Maura Parte attended the UNESCO Conference on World Higher Education in Paris, France and they had the opportunity to meet with several student unions who expressed interest in rebuilding the International Union of Students. She said that communication tools have become more sophisticated which makes it easier to continue rebuilding the International Union of Students internationally. She said that members of the Federation should be proud of their role in this work, there have been three student unions around the world playing a key role, Germany, Canada and Libya. She said that students in Latin America and in the All African Student Union are interested in becoming more involved.

4. NATIONAL EXECUTIVE QUESTION AND ANSWER PERIOD

Local 44 delegate Linda Szasz thanked the National Executive for the information on changes to the bankruptcy and insolvency act which was distributed to locals in August. She asked what strategy had been developed to address the changes to the bankruptcy and insolvency act. She asked for more information regarding the Charter challenge.

Carlyle said that in preparation for the court challenge and the introduction of the private member's bill, anecdotal evidence regarding student debt and experience with the bankruptcy legislation is being solicited and gathered. She said that a toll free line is in operation in the national office for the purposes of collecting this information. She said that members should refer students to the toll free line or to the Federation's Researcher. She said that this information is being used in lobby sessions. She said that a list of provincial and federal student financial assistance is being compiled. She said that an information sheet is being developed which will provide answers to commonly asked questions about student financial assistance. She said that the court challenge is in the research phase. She said that a twenty four page considered opinion has been prepared by the Federation's lawyers. She said that the challenge is a section 15 Charter challenge on the basis of age. She said that the Federation is contending that the new bankruptcy legislation, the ten year ban on claiming student loan bankruptcy, discriminates against people on the basis of age. She said that majority of student loan debt holders and former students who apply for bankruptcy protection are under the age of 30. She said that in the meeting with Finance Minister Paul Martin he could not provide rationale for the changes to the legislation. She said that he claimed that the new measures in the 1998 Federal budget should eradicate the need to declare bankruptcy. She said that a suitable test case is being sought. She said that the campaign will be built in conjunction with the campaign against corporate rule.

Local 44 delegate Morgan Stewart said that the web page is one of the most effective tools of communication amongst the rank and file members. He said that the November 1997 campaigns committee made a number of suggestions which were not implemented. He said that the debt wall is a simple guest book format but the direction from the committee was to include more information including institution, name, and program of study. He said that this detailed information could be used by the Federation in its research and during lobby sessions. He said that the other direction was to include information for the January 28, 1998 Day of Action. He said that the information was on-line for the October 1998 Days of Action. He said that the Federation has a number of research documents which provide background information and are crucial to the work of the organisation. He said that the Federation should consider including these documents on the web site, thus making it available to the media and the membership.

Carlyle said that students visiting the debt wall site decide how much information they wish to include. She said that the national office has not investigated the feasibility of establishing a site where the information will remain completely confidential. She said that the both the National Executive and the Campaigns and Government Relations committee at the May 1998 national general meeting have debated which documents should be provided on the web site. She said that the debate has not been resolved. She said that media releases have been posted on the web site in a more timely fashion. She said that the National Executive has also considered a 'members only' portion of the web site which would include documents not currently on the site.

Local 19 delegate Baines asked about the status of the following directives: the provision of Constituency Group Commissioner resource guides; updating the boycott list; the provision of information regarding Text Express; and the provision of the National Executive Report to the membership before the November 1998 general meeting.

Carlyle said that the Constituency Group Commissioner resource binder was completed and distributed two months ago. She said that the boycott list has not yet been updated. She said that the National Executive was unable to prepare the report before the November 1998 national general meeting so they made it a priority to have it prepared so delegates could review it during the course of the general meeting.

Hansen said that work is ongoing on the Text Express directive. He said that work was not completed before the completion and distribution of the 1998-99 Studentsaver Card because Text Express amended the original offer and it became apparent that they could not offer the same bonus to all students receiving the Studentsaver Card. He said that if the information is available at the May 1999 national general meeting it will be presented to the members for consideration.

Local 68 delegate Michael Erikson said that the National Executive should ensure that member locals are informed immediately of any changes to campaigns timelines. He said that many of the campaign materials called for a tuition fee freeze but did not indicate that it was a first step towards the elimination of all user fees. He said that the campaign regarding the Red Cross is broader then the title of the campaign in the National Executive report suggests. He said that the campaign should be more develop at this point because it has existed for three years. He asked about the status of the directive calling for the promotion of participation of students' of colour in local student unions. He asked that National Executive members indicate the items they are responsible for.

Carlyle said that provincial components were asked to relay information regarding campaign timelines to member locals. She said that no specific text for the campaign materials was established by the members at the May 1998 national general meeting. She said that the National Executive will consider his comments regarding text into consideration before developing more materials. She said that the actual name of the Red Cross campaign is 'Campaign Against Homophobic Red Cross Questionnaire'. She said that the Ontario and Manitoba Representatives were assigned the Red Cross directive but the Ontario Representative has recently resigned. She said that the Manitoba Representative is now working on the campaign with the *TGLB Commissioner. She said that the Students' of Colour Representative is responsible for the campaign to increase participation of students' of colour in student unions and on Boards of Governors. She said that the National Executive report includes an update.

Local 8 delegate Margaret Bryans said that the Alternative Federal Budget (AFB) originated in Manitoba through the efforts of the Coalition for Social Justice (CHOICES) which originally developed the budget. She said that it was developed to empower citizens with knowledge about the budget and the budgeting process. She said that the Manitoba component is concerned that the Federation and other groups have turned the focus away from citizens participation in the budget and are focused on using the AFB as a media tool and a lobbying tool. She said that the Manitoba component is committed to making budgets accessible to people and believe that the AFB is a powerful tool in challenging the government's assertions. She said that she was informed that the 1999 federal budget would have more input from community groups then the AFB would.

Story said that the AFB is a coalition of national organisations and regional coalitions so it would be impossible for the federal budget to receive more input. She said that the AFB is the product and tool of a citizens' movement. She said that there is no intention to use the AFB primarily as a media tool. She said that a steering committee works on the content and CHOICES coordinates the animation of the budget by establishing AFB schools. She said that a variety of other organisations ensure that their members receive and understand the budget. She said that although the AFB has existed for 6 years only 20% of the population are aware of its existence which is a problem the steering committee wants to address. She said that increasing the profile of the AFB is not being done at the expense of grass roots education.

- Recognises a minimum which widens the gap between income level for individuals based on rates from the National Council on Welfare;
- Supports the use of National Council on Welfare low-income cut-off rates to establish levels of assistance and to determine the effectiveness of programs; and

In addition, the Federation supports the elimination of all financial barriers to post-secondary education (refer to Issues Policy: Accessibility). Post-secondary institutions levy up-front user fees to subsidise operating costs. The Federation fervently opposes any proposals which advocate for tuition fees as a solution to the problem of under-funding. Systemic under-funding has increased the financial burden sustained by students in post-secondary institutions through up-front user fees.

The Federation believes that the government must consider the realistic costs of post-secondary education above and beyond tuition fees and ancillary fees. Furthermore, the Federation believes that student aid line item levels should be adjusted annually to reflect the costs associated with the attainment

of a post-secondary education, and that this adjustment should reflect regional differences in the cost of obtaining a post-secondary education (refer to Issues Policy: Student Aid).

Need is defined as circumstances requiring some course of action in times of difficulty or crisis, often described as destitution or poverty in extreme circumstances. The Federation recognises there are varying financial requirements between students pursuing studies in colleges/technical institutes, undergraduate programs, and graduate programs. The Federation also recognises the unique financial needs of students with disabilities and international students. Therefore the Federation recognises that it is essential to identify various parameters in determining the financial needs of these different groups.

The following criteria should be included in any assessment of need:

Living Expenses:

- rent/mortgage
- car/transportation
- monthly bills
- food/household/hygiene
- trips home
- clothing
- moving costs

Post-secondary Education:

- up-front user fees (tuition, ancillary, etc.)
- books/program supplies/equipment
- currently held scholarships, stipends, research granting council funding

Research:

- travel/conferences
- publishing
- thesis production costs
- academic subscriptions

Employment:

- full-time versus part-time
- income
- assets

Debt:

- previous student loans
- line of credit
- credit cards

Other:

- disability
- age/mature status/ grad
- dependants

- research expenses including travel, conference fees, publishing expenses, thesis production costs and academic subscriptions;
- a student's existing indebtedness through credit cards, a line of credit or other loans; and
- emergency costs arising during the study period.

Resources calculation

The Federation:

- recognizes scholarships, research granting council funding and employment income as resources for the purpose of calculating need;
- opposes the inclusion of family or parental income in the assessment of need.

6. PRESENTATION OF THE BUDGET COMMITTEE REPORT

Hansen said that the Budget Committee used a slightly different budgeting process which expedited the proceedings. He said that the Budget Committee decided to alter the structure of the budget starting in the 1998-99 year. He said that the old format of the budget did not include some of the line items now included in the budget. He said that the Federation realised significant savings in the 1997-98 year due to the high number of staff vacancies which were budgeted for to be filled for a full year. He said that these savings enabled the Federation to finance some activities which otherwise would not have been possible. He said that the May 1999 Budget Committee will have some difficult decisions because it is unclear if the Federation will be able to maintain the level of expenditures. He said that in the 1998-99 budget the Federation has under \$2 million in revenue. He said that just over half of that money is from membership dues and the remainder is derived from the Federation's various programmes. He said that the Federation's membership fee revenues have increased slightly which is a reflection of improved enrolment figures in British Columbia.

Hansen said that new equipment will have to be purchased by 2002 to produce the reformatted International Student Identity Card. He said that a number of member locals will not be able to afford the electronic hardware and software so the Federation has to budget to pay for this equipment. He said that the donations line item has increased to reflect the various requests from caucuses and constituency groups. He said that the Aboriginal Caucus allocation is now called an expense because there is no Standing Resolution in place governing the amount. He said that it has been increased to account for an increase in work and activity. He said that constituency allocations are up slightly because the membership fee revenue is slightly higher. He said that the disabled access line item in the general meeting schedule has been lowered to account for the removal of ASL/LSQ interpretation to the interpretation line item. He said that the meetings and conferences line item had an asterisk because in 1997-98 they did not cost over \$30,000. He said that the asterisk is to note that the number is high because of difficulty breaking down the costs but the number would be lower in 1998-99. He said that the \$30,000 reflects the money formerly in the National Executive expenses line item. He said that it was difficult to determine where each of those expenses would have gone.

Hansen said that the legal line item has increased by \$10,000 to reflect the lawsuits the Federation is involved in. He said that the Federation anticipates winning the lawsuits and recovering the expenses. He said that the translation line item has been separated from the interpretation expenses. He said that no money has been allocated for the public inquiry because the Budget Committee was unsure of the costs involved. He said that the contingency line item can be accessed to cover the costs associated with the inquiry and other line items which exceed the budgeted amount. He said that the costs of simultaneous interpretation are not included in the 1998-99 budget because the money has already been allocated in previous budgets. He said that half of the money in the bilingualism fund will be used at the May 1999 national general meeting. He said that the bilingualism line item will have to be re-evaluated to ensure that sufficient funds are available to continue the Federation's commitment to bilingualism. He said that the translation line item is an expense which is determined on a yearly basis. He said that if the money is not needed it will be used elsewhere. He said that putting money into the bilingualism fund ensures that it is not re-allocated and can accrue.

Local 1 delegate Claire Gilbert asked why some components did not have individual schedules in the budget.

Hansen said that the Federation provides components with subsidies in two ways. He said that some components, primarily those with fieldstaff funded from the provincial budget, receive a cash transfer from the national budget to the provincial budget. He said that the transfer is one sixth of the membership fees collected in the province. He said that at the May 1998 national general meeting additional money was included in the Saskatchewan Component line item to reflect the additional membership development work required. He said that the detail in the staffing line item reflects the staff positions which are paid for by the national budget. He said that the exception is the Newfoundland and Labrador Component schedule. He said that the money in the budget reflects a staffing position which is temporarily replacing the allocation.

He said that this day should be used to highlight the progress of international students. He said that the International Students' Commissioner should assist with this task. He said that he and Monica Gasparic from Local 73 will be co-commissioners for the remainder of the 1998-99 term.

Carlyle said that November 17 was a date selected by the International Union of Students and is intended to act as a day to commemorate the massacre of students in Prague on 1949. She said that it is a day for students all over the world to celebrate.

e. Women's Constituency Group Report

Nembhard announced that Margaret Bryans was elected as the Women's Commissioner for the remainder of the 1998-99 year.

f. Aboriginal Caucus Report

Local 71 delegate Green said that many concerns were raised regarding the decision of the National Executive to overturn the Aboriginal Caucus elections. She said that the Caucus and the National Executive met at the national general meeting and discussed the issue which was productive.
