 Development Committee: accept proposals for long and short term goals - the constitution will be established on the basis of the proposals.

 Budget Committee: has three goals: i) short term budget ii) request for fee waivers iii) long term financial plan. This committee should work with the Development Committee.

3. Referenda Committee: techniques developed for referendum. Support services for campus referendums.

4. Campaign Committee: this is an ongoing need in the structure of CFS.

Constitutional Proposal

Canadian Federation of Students/Federation Canadienne des Etudiant(e)s

- 1. We the students of British Columbia, realize the need to speak with one voice, and we express our support for one national student organization. where basic aims will be:
 - a) To realize that each individual, as a student, is equal;
 - , b) To organize students on a democratic co-operative basis;
 - c) To guarantee local member autonomy;
 - d) To advocate and protect the rights of students as citizens in an international community;
 - e) To achieve necessary educational, administrative, legislative, and social change to make post-secondary education universally accessible;
 - f) To represent students and receive complaints, investigate problems and decisions affecting students;
 - g) To create a comprehensive perspective of education in communities of British Columbia and in Canada, realizing that we are students in a global community;
 - h) To promote educational, cultural, social and athletic environments for the benefit of all students;
 - i) To realize the autonomy of Canadian University Press and student newspapers organized on a democratic basis;
 - j) To recognize the constitution and the standing resolutions of the Cunadian Federation of Students.
- 2. The society shall be carried on with no profit accruing to its members and any operation surpluses shall be used to further the purposes of _____.
- 3. Upon the winding up or dissolution of the society any assets of the above remaining after the satisfaction of its debts and liabilities shall be given or transferred to such an organization or organizations in British Columbia promoting objects similar to those set out in paragraph 1 herein as may be decided by the members of the society at the time of winding up or dissolution. This clause is unalterable.

4. The operations of the society will be carried out chiefly in the province of British Columbia.

STANDING RESOLUTION COMMITTEE-AT-LARGE

General Description

The Committee-At-Large is an informal body which shall consist of registered members who shall promote the goals, objectives, and policies of the CFS-Pacific and shall perform any other duties as should be in accordance with the needs and desires of the CFS-Pacific.

- All students in good standing, as defined by their local student association, shall be eligible for membership in the Committee-At-Large.
- II. There is no minimum or maximum to the number of possible registered members of the Committee-At-Large.
- III. Each person who wishes to be a member of the Committee-At-Large must register with the Executive Committee; providing the following information:
 - i) the person's name, address, and telephone number, skills and special interests.
 - ii) in which local student association the person is a member.
 - iii) the registrant's interest in becoming a member of the Committee-At-Large.
 - iv) time available to do projects.
- IV. According to the provisions of this resolution, one may register for the Committee-At-Large at any time and may resign at any time.
- V. Each member of the Committee-At-Large must re-register with the Executive Committee after every General or Annual General meeting in order to remain a member of the Committee-At-Large.

Responsibilities of the Members of the Committee-At-Large

- The members of the Committee-At-Large shall perform as a member with diligence and integrity.
- II. Should a member of the Committee-At-Large be unable, or unwilling, to perform any particular task which she has accepted, said member shall inform with reasonable dispatch the Executive committee of this situation.

- I. Members of the Committee-At-Large may meet at any time to discuss any matter.
- II. There shall be no required quorum or set of rules for meetings of the Committee-At Large.
- III. Every member of the Committee-At-Large may attend any and all meetings of the Executive Committee subject to in-camera.
- IV. Procedures to define the rights and responsibilities of members of the Committee-At-Large as related to Executive Committee meetings shall be detailed in a Standing Resolution.
