

The committee meets approximately once a month to review student aid appeals and make decisions on whether the rules should be suspended. Student representatives must be full-time students. The Ministry will pay for travel to and from the one day meetings.

(hereinafter called the 'Company')

OF THE FIRST PART

AND:

CANADIAN FEDERATION OF STUDENTS PACIFIC REGION, of 213 TC, Simon Fraser University, in the Municipality of Burnaby, in the Province of British Columbia;

(hereinafter called the 'Society')

OF THE SECOND PART

WHEREAS:

- The Company is duly incorporated under the laws of the Province of British Columbia;
- The Society is duly incorporated pursuant to the laws of the Province of British Columbia:
- The Company and the Society are desirous of entering into agreements between them for their mutual benefit;

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of good and valuable consideration (the receipt of which is hereby acknowledged) and the mutual covenants, promises and recitals contained herein, the parties hereto agree as follows:

- The Company will undertake to act on the Society's behalf with regard to the acquisition of property, the preparation of architectural plans and renderings, and the presentation of projects for the purpose of the Society acquiring low income housing projects or such other housing projects as the Society may designate.
- The Company shall, for the further benefit of 2. the Society, approach and deal with all Government and regulatory bodies, and without restricting the generality of the foregoing, including the Municipality of Burnaby, the Canadian Central Mortgage and Housing Corporation, and all such other persons, firms, agencies, regulatory boards and Government agencies to assist in the acquisition, preparation and construction of any housing project that the Society instructs the Company to undertake and complete.
- The Company shall further, for the benefit of the Society, assist in the obtaining of financing for any

such housing project from the Canadian Central Mortgage and Housing Corporation, or from such other source as may be appropriate in the circumstances.

- 4. Upon the successful acquisition, financing and completion of any given housing project, the Society agrees that the Company shall manage and administer such project for a minimum period of one year from substantial completion of said project, with an option to review the said management and administration of the project for a further period of one year, upon such further terms and conditions as may be agreed to in writing between the Company and the Society. Upon the conclusion of the Company's management and administration of any project, at the expiration of such agreement, or by the non-exercise of such option, the Company agrees to turn such administration and management of any given project to the Society.
- 5. In the event that the Society wishes to manage and administer any given project, the Company will render such additional consulting services to the Society upon such terms as may be mutually agreed upon in writing.
- It is further agreed and understood that, should

incur any cost for the acquisition of property, the preparation of architectural plans and drawings, and any other expense in connection with the presentation of a project which is not accepted by the Canadian Central Mortgage and Housing Corporation, then the Society shall bear no cost or expense in this regard.

INTRODUCTION OF CANADIAN FEDERATION OF STUDENTS - PACIFIC REGION

- 1. The purpose of this document is to assist Canadian Federation of Students, Pacific Region (hereinafter called C.F.S.) in any or all of the following matters:
 - a) In more properly understanding its role and responsibilities in the matter of any type of housing projects it may wish to undertake.
 - b) Embarking upon a specific procedure to identify particular needs for housing projects, and the criteria by which that need is to be measured.
 - c) An orderly process of assembling, approving and completing a given housing project.
- 2. The starting point is to make an initial introduction of C.F.S. C.F.S. should set out and be in a position to justify the following:
 - a) Its goals and objectives as defined by its Charter.
 - b) Its membership base.
 - c) Its over-all financial resources.
 - d) the process by which a given housing project would be approved, for example, whether it is on the basis of a decision by the executive committee, or a simple majority vote of all the Members.
- 3. C.F.S. must decide on their specific needs as they pertain to the question of a housing project. These factors include:

- a) What type of housing should be considered.
- b) Hand-in-hand with the type of housing that is being considered, what is the specific need that the housing wishes to deal with.
- c) How has the need been determined as a result of surveys; as a result of a poll; or as a result of a petition or some other form of campaign.

 It is to be emphasized that once a particular need has been identified, C.F.S. may be entitled to a start-up Grant from the Central Mortgage and Housing Corporation to pursue the matter further.
- 4. After a specific need has been identified, and presumeably after a start-up Grant has been given to C.F.S., it is the function of KJAM Management Corporation to actively pursue, obtain and assemble a specific type of project that C.F.S. has indicated it would wish to construct. That particular relationship between C.F.S. and KJAM Management Corporation has been made the subject of an Agreement, the highlights of which are as follows:
 - a) KJAM will deal with all the necessary levels of Government on behalf of C.F.S.
 - KJAM would in effect assemble and build the project from beginning to end.
 - c) KJAM would manage the project initially for a period of one (1) year, and thereafter for such further terms as may be mutually agreed to.
 - d) It is to be emphasized that C.F.S. is not obliged to pay KJAM any fee for any contemplated projects that, for whatever reason, do not get approved or constructed, except for such

disbursements that will be specifically authorized by C.F.S.

- It is obviously the case that the first of the type of project that is contemplated by both C.F.S. and KJAM Management Corporation would hopefully be a management model for future projects, which C.F.S. could manage on its own, or continue to have KJAM Management Corporation manage on its behalf.
- 6. Any additional information that C.F.S. would require will be gladly provided by any of the principals of KJAM Management Corporation.
