All of these topics have been discussed thoroughly by the delegates at one level or another or at committee meetings. This report will only include some of the more major points that we touched on in our debate.

1. national organization not accessible from local perspective because of lack of common vision and clear direction - allocation of resources renders it ineffective in meeting our needs at the political advocacy level and consumer service level.

2. - more coordinated and effective lobbying work on all levels

- more research, information services and organizing assistance for locals

- \*\*critical\*\* - assistance to develop functioning student associations, including the hiring of local staff

- network development - communication between campuses for problem solving

- provincial fieldworker (of some kind, i.e. new direction)

- direct, low cost membership services

- skills development at all levels - local and provincial reps

3. Removing congruency at this general meeting may:

a) destabilize locals allowing different interest groups to take advantage of the organization's transition

b) less credibility for those prospective members soon to run membership referendums

c) possibly less political clout - narrowing your base of support

d) less financial resources for development of other provincial organizations ...4

4. Alternatives to National Organization

- hiring our own researcher/lobbyist in Ottawa (cheaper, more focussed in their work

- maintaining national communication through conferences, on a more informal basis

- associate membership in Services

- strong locals and regions make a strong national

- resources spread too thin weaken all aspects

- students must have a national forum
- must have a voice at Federal governmental level

- a national organization should be in a position to effect social change at a national level

MOTION for Final Plenary

'The committee recommends to table the motion to the next general meeting; recognizing its intent of positive motivation'.

Direction for the development committee to reallocate the budget in a way to begin to address the problems we've outlined ant to develop a mechanism to transfer money back from the national for provincial administration and search for other sources of revenue in the short term.

## APPENDIX II

## ELECTION PROCEDURE.

## Notice

Notice of positions to be elected, job descriptions, eligibility requirements, and of the election procedure should go out in the first notice of general-meeting.

## Nominations

Nominations for all postions should be opened at the opening plenary. As well, a time for <u>closing nominations</u> should be set for midway through the general meeting. At this point, the chief returning officer shall announce which nominations are valid. Nominations must be moved and seconded by delegations at the general meeting.

## Circulation

Candidates will submit with their nominations a one-page letter and a résumé (maximum of 2 pages). These documents will be circulated by the chief electoral officer at the close of nominations.

# Candidates' Grill

At the opening plenary, a committee consisting of the chief electoral officer and of two persons (not running for office) selected by the plenary shall be struck. The committee will prepare a set of questions for each position, and will put the questions to each of the candidates for each position, and will put the questions to each of the candidates in the grill session. The committee's questions have been answered, a 15 minute open question period will be held for each position, for delegates to put questions to the candidates.

## Voting

The chief electoral officer will prepare ballots, one for each voting member local associations. 10 minutes will be put aside for delegations to caucus over their choice. Ballots will then be collected by the chief electoral officer, and counted in a separate room. Each candidate has the right to have a scrutineer present at the ballot counting.

Candidates must win on a 50% majority basis. That is, if one candidate does not get a majority of all votes cast, a run-off vote will be conducted.

Candidates running unopposed will go through the same procedure, and will be elected on a YES/NO ballot.

## Eligibility

As outlined in the Federation's constitution and by-laws, the following are requirements that the candidates for office must meet:

- a) Candidates for at-large positions on the executive committee must be authorized by a member local association to represent that member local association as a delegate to the general meeting; or candidates must have been a member of the executive committee up to the time of the meeting at which the election is held, provided that such executive members are members in good standing of a member local association.
- b) There shall be a minimum waiting period of one (1) year before a candidate who has served two (2) consecutive terms on the executive committee shall be eligible for re-election to the executive committee, unless waived by two-thirds of a Federation plenary.
- c) There shall be no more than two (2) executive committee members from any member local association.

\*The women's liaison is elected by the women's caucus. This position is to be elected at the October women's assembly, but that assembly did not happen this past year. A women's caucus of the general meeting should be struck to at least deal with this election.

# DEVELOPMENT COMMITTEE

# FINAL REPORT

The committee recognized that there were definite problems in the overall development of a strong national student organization, and that the major part of those problems was a lack of strong provincial federations to do the necessary organizing and development of locals.

It was felt that money must be obtained to move development forward, and that for the time being some of the money should come from the national and services budgets. The committee did identify some areas of expenditure that it thought were extraneous to the basic work of the organization: the Canadian Programming Service, the Information Resource Service, reducing staff in the services office, eliminating the Bulletin, reducing general meetings to one each year, and not to have materials for mass distribution to students produced in the national office. It was recognized that some sort of agreement about the publicization of the national programs would have to be drawn up between the provincial and national organizations. Of course, these are just suggestions to be developed in the following motions.

<u>MOTION</u>: Be it resolved that the executive and staff develop a proposal for a Provincial Development Fund to be created from the two national budgets to the total of \$1/full member/year' Be it further resolved that through their local representatives, member local associations contribute to this proposal.

This proposal will have to be completed well before the notice deadline for the national general meeting in May, so that it can be distributed to the other members across the country for further development.

## RESEARCHER

MOTION: Be it resolved that the researcher position be established as a permanent position.

# OFFICE

<u>MOTION</u>: Be it resolved that \$3000 be reallocated from the general meeting (\$2000), donations (\$500), and contingency (\$500) to establish a new regional office.

It was recognized that the current location at SFU was isolated, and that it created a problem because space is at a premium for the Simon Fraser Student Society.

# DEVELOPMENT COMMITTEE REPORT/2

# SUPPORT FOR LOCALS

It was recognized by the committee that more time had to be spent developing some of the local associations so that they can be stronger and more fully participate with other members of the Federation. It was felt that trips of a week or so in duration by Federation staff and executive to isolated or underdeveloped locals would greatly improve the situation.

<u>MOTION</u>: Be it resolved that \$1500 from contingency be reallocated to the staff and executive expense line items to more vigorously pursue local association development.

# NATIONAL REPRESENTATIVE

It was agreed that the national executive representative should spend more of the telephone line item to keep in contact with locals and the provincial office between executive meetings.

It was also agreed by the committee that the national executive representative should see it as a priority to orient delegates to each national general meeting.

It was also felt that sending staff people to national executive meetings was good in several ways: it allows for continuity, provides support for the representative, gives staff a chance to meet with others across the country, and allows for professional development.

MOTION: Be it resolved that a staff person be sent to the August and January national executive meetings.
